If the student cannot produce their license, the Instructor will drive the student, on their instructional time, to pick up their license or cancel the lesson and charge a rescheduling fee.

One completion certificate is provided upon course completion and is included in the program cost. A duplicate certificate can be obtained for a fee of **\$25.00 incl GST.**

THE DRIVING SCHOOL

1. The driving school will provide the training in a timely and professional manner. See the school information email for more details.
2. The Driver Training vehicle will be clean and in good running condition. The vehicle will have a valid license plate, registration, and insurance.
3. All our Driving Instructors are licensed by Alberta Transportation and will produce their Instructor's License and Operator's License upon request.
4. If the driving school must cancel a lesson due to instructor illness, vehicle breakdown, etc., every effort will be made to accommodate the students and to reschedule the lesson as soon as possible.
5. The driving Instructor will give full attention to the student during the in-vehicle lesson. The instructor's cell phone will be off and may not be used unless the vehicle is safely stopped and the student gives permission.
6. An in-vehicle report card/student summary with a detailed evaluation will be completed by the Instructor and explained at the completion of each lesson.

THE STUDENT

1. Student's must hold the minimum class of license required for training
 - Class 7 is the minimum class of license required for class 5 and 6 training
 - Class 5 GDL is the minimum license required for class 1,2,3,4 training
2. Students must be the appropriate age. The minimum learning age is:
 - 14 for License class 7
 - 16 for License class 5-GDL
3. A student who attends a course that offers a "Driver Education Course Completion Certificate" must have the required minimum hours of training for the specific course and must ***PASS** the applicable examinations as approved by Alberta Transportation.
 - **An In-Vehicle passing grade of at least 75% and a Classroom/Online grade of at least 80% must be obtained to be issued the Completion Certificate.*
 - *** STUDENTS MUST COMPLETE ALL LESSONS FOR THE CERTIFICATE TO BE ISSUED**
4. Any acts of negligence on the student's part that results in damages or fines will be the full responsibility of the students and/or their parent/guardian.
5. Learning to drive must be taken seriously. Students are expected to give their best efforts during classroom and in-vehicle lessons. Unacceptable behaviour (drinking, drugs, swearing, continually late, etc.) will not be tolerated, and the Driving School may discontinue the lesson at the student's expense.

NOTE: The student must have their license in their possession during in-vehicle training; the Instructor will check before the start of each lesson.
6. Payment must be made in full in order to finalize program registration. No classroom or in-vehicle instruction will occur until registration is completed.
7. During Driver training lessons, in-classroom, or in-vehicle, all electronic communication devices (e.g., Cell phones) are not to be used by the student.
8. Students must provide 24 hours cancellation notice of an in-vehicle lesson to allow the driving school time to reschedule vehicles and instructors. (Note: In cases such as student illness, the driving school will use discretion). If a lesson is missed and there is no valid reason, a penalty fee of \$50.00 + GST may be assessed.
